- 2.3) The Applicant hereby represents that all data and documents that it has provided to POZAGAS a.s. in this Application and/or during Applicant registration are true, complete and correct and should this prove not to be the case, it will assume all legal consequences and liability for any ensuing losses.
- 2.4) The Applicant acknowledges that a failure to complete this Application upon instructions specified in this Application or upon instructions published by POZAGAS a.s. may cause the Application to be dismissed.
- 2.5) The Applicant hereby represents that it will submit to POZAGAS a.s., no later than three (3) working days before the Nomination submission, a shipper code assigned by relevant Connected Network Operator. If the Applicant fails to submit the shipper code under the preceding sentence, POZAGAS a.s. is entitled to postpone commencement of provision of a gas storage service by the number of working days of Applicant's delay.
- 2.6) The Applicant hereby confirms that it is entitled to dispose of Gas designated for storage in the Storage Facility pursuant to the Gas Storage Contract.
- 2.7) The Applicant hereby represents that is it not being wound up and that no bankruptcy or restructuring proceedings or similar proceedings under applicable national legislation have been commenced against it and that no petition requesting that it be declared bankrupt has been dismissed because of insufficient assets.
- 2.8) The Applicant hereby represents that in case of Storage Capacity allocation based on this Application it shall conclude Gas Storage Contract with POZAGAS a.s. within period specified in Article 11 of the Rules of Operation.
